1. Opening the meeting

Anna Sihvonen opened the meeting at 19:03.

2. Organization of the meeting

Pranava Varshan was selected as the chair of the meeting. Kiia Koskinen was selected as the secretary of the meeting. Ojaswi Tyagi and Christian Guidikov were chosen as the minutes inspectors of the meeting. Khanh Hoang and Napat Borvornpadungkitti were selected as vote counters. It was decided that the minutes inspectors will work as the deputies of the vote counters and the vote counters will work as the deputies of the minutes inspectors.

3. Legality and quorum of the meeting

4. Accepting the agenda for the meeting

6. **Annual report for 2025**

The chair of the 2025 board, Anna Sihvonen, presented the annual report for 2025. The guild meeting decided to record the discussion about the annual report for 2025.

7. **Financial statements for 2025**

Anna Sihvonen presented the status of the financial statement for 2025. The financial statement for 2025 was not ready on time for the meeting.

Ojaswi asked if questions can be asked during the presentation, to which Anna answered that they can.

8. **Statement from 2025 operations inspectors about 2025 financial statement**

9. **Accepting 2025 financial statement**

11. The membership fee amount proposal for the academic year 2026-2027

The chair of the 2026 board, Pranava Varshan presented the membership fee amount proposal for the academic year 2026-2027. The proposal for the academic year 2026-2027 is to have the membership fee cost 7€ and to add a sponsorship membership, which will cost 25€. As decided in the election meeting 2022, the annual membership fee due date is on October 1st. The membership fee due date for the academic year 2026-2027 will be on October 1st, 2026.

The membership fee amount proposal for the academic year 2026-2027 was accepted by the guild meeting.

12. Operation plan for 2026

The chair of the 2026 board, Pranava Varshan, presented the operation plan for 2026.

Christian suggested changing one of the focus points to “begin archiving the history of the guild and beginning the pipeline for guild honours” instead of “archiving the history of the guild and beginning the pipeline for guild honours”. The majority were in favour of the amendment of the base proposal.

The operation plan for 2026 was accepted by the guild meeting.

13. Budget for 2026

The chair of the 2026 board, Pranava Varshan, presented the budget for 2026.

Ojaswi asked what the expenses under volunteers mean. Pranava clarified that it means the board and tutors.

Jonasz asked if there is no need for a profit for the guild room, to which Pranava answered that there is no need to make a profit from the guild room.

Aawez asked where the income for new students comes from. Pranava answered that they come from SCI and the fuksi guides. The sponsorships are under general operations.

The budget for 2026 was accepted by the guild meeting.

14. Selecting the operations inspectors for 2026

Katsuya Kurosawa was selected as an operations inspector for 2026 during the elections. There were no volunteers for the second operations inspector. The operations inspectors and their deputies for 2026 will be selected in a future board meeting.

15. Accepting new guild members

Kiara Akshaya Basa and Minh Duc Nguyen were accepted as members of the guild.

16. Other issues

There were no other issues to be discussed.

Anna Sihvonon closed the meeting at 19:23.




